

BA / Not a BA Checklist

To maintain compliance with the federal HIPAA regulations when disclosing protected health information (PHI), covered entities (CEs) need to know when the person or entity they are disclosing to is their "business associate"(BA) and get written certain "assurances"(a contract, a memorandum of understanding) from each BA . This checklist is designed to help you do this.

For each potential disclosure of protected health information (PHI)to a third party, ask the questions below until you reach "not a BA", "BA" or "BA / Workforce".

The "Workforce" alternative –

When a potential BA is going to be working on the Covered Entity's premises, following CE policies and procedures, or subject to direction and instructions from the CE, another alternative is to treat the BA and BA employees as members of the CE "Workforce". No written "assurances" are then required, but workforce members must be trained by the CE.

**BA = Written Contract
Workforce = Training**
